



- Participation implies that the contracts in the trading system will be concluded **on behalf of the broker and for account of the customer**



Select a foreign broker:

1. Broker – a trading participant included in the List of Trading Participants Acting on Behalf and for Account of Other Persons.
2. Customer – a foreign legal entity.
3. Agreements to be concluded: Clearing Services Agreement, Agreement on Joining the EIS Rules.

Acting as a Trading Participant and operating on their own behalf and account also implies concluding an Agreement on provision of services for conduct of organized trading and an Agreement on provision of SPIMEX of software and/or technical means for remote access to services rendered by the Exchange


